3. Allow 3-4 weeks to complete proposed work. Allow proper cure time for caulking prior to filling pool.
4. After this work is completed all of the piping on the interior of the pool will be left plugged and owner to fill the pool incrementally and monitor until full if insignificant water loss is determined. Owner to monitor the water level for 1 week to determine any water loss if applicable. After the initial one week water monitoring is completed and if water level appears to be maintaining, NP will send a diver to remove the plugs in the pool piping and owner to monitor the water level for an additional week to determine if there is any water loss with plumbing open.
5. If there is still a substantial leak after this work is completed, National Pools will return at no charge and perform a dye check on the pool interior to attempt to locate additional leaks in the pool structure and/or piping. A maximum of 2 additional trips is included in this price.
